Dear Homeowner/Resident,

Edison Glen Condominium Association is happy to announce that the pool will be open for the 2017 season as stated below:

**Memorial Day Weekend – May 27<sup>th</sup>, 28<sup>th</sup> and 29<sup>th</sup>**  
**June 3<sup>rd</sup> & 4<sup>th</sup>**  
**June 10<sup>th</sup> & 11<sup>th</sup>**

**7 days per week from June 17<sup>th</sup> up until Labor Day - September 4, 2017.**

The hours of operation will be as follows:

**12:00 PM – 8:00 PM Daily**

For your convenience, **all pool registrations (new and renewals)** will be conducted at the management office **every Tuesday between 11am and 2pm, Wednesday between 11am and 6pm, and Friday between 11am and 2pm beginning Tuesday, May 2, 2017.**

Please bring the following information when registering for the 2017 pool season:

- The fully completed Pool Registration Form
- Proof of residency for all individuals in the home
  - Driver's license, voter registration, recent utility bill or bank statement
- 1" x 1" recently taken passport photo if applying for a **new** pool pass
- If you received a pool pass in 2016, please bring that pass to obtain your 2017 validation sticker.
- **IF YOU ARE A TENANT, YOU MUST PRESENT A VALID COPY OF YOUR CURRENT LEASE BEFORE POOL PASSES WILL BE ISSUED, EVEN IF ONE WAS PREVIOUSLY PRESENTED. PLEASE NOTE THAT THE PROOF OF RESIDENCY IS NOT TO AGGRAVATE RESIDENTS BUT RATHER TO ENSURE ONLY**

PEOPLE WHO RESIDE IN THE COMMUNITY HAVE ACCESS TO THE POOL.

- To register children who will be between the ages of 13 and 18 of age by June 30, 2017, proof of residency, proof of age (birth certificate and/or any school document) and a 1"x1" photo must be presented. Children between the ages of 5 & 12 require a non-photo I.D. pass. Proof of age and residency apply. Children 4 years old and under do not require a pass of any kind.
- There is a \$5 charge for each new pass. There is no charge for renewals. **There is a \$10 replacement fee for all lost passes.**

**LATE REGISTRATION**

We suggest that you renew your passes during the dates provided even if you're not sure of your intentions to use the pool. Registrations after the dates provided will take place by appointment only. Please contact the management office at 732-321-3371 if you miss the dates.

Each homeowner will be provided 2 guest passes. Additional guest passes may be purchased at a cost of **\$5.00 per day at the management office; they will not be sold at the pool by lifeguard.** (Management office is open every Wednesday from 11:00 AM – 7:00 PM for your convenience.)

Without a resident pass or guest pass you **cannot** obtain access to the pool. **RULES WILL BE STRICTLY ENFORCED. Guests are only allowed in the pool with a resident.**

**ANY UNIT OWNER WITH UNPAID ASSOCIATION FEES, LATE FEES AND/OR FINES, WILL NOT BE ISSUED PASSES UNTIL THE ACCOUNT IS PAID IN FULL. IF AT ANYTIME DURING THE SEASON A HOMEOWNER BECOMES DELINQUENT, THEY WILL BE DENIED ACCESS TO THE POOL BY THE LIFEGUARD.**

Please take a moment to read the pool rules. These rules are for everyone's safety and enjoyment. **THEY WILL BE STRICTLY ENFORCED.**
